


Executive Reports

Provincial President

Georgia Steinhart

When you read this message we will be midway through the final term of the school year, with summer holidays beckoning in the not too distant future. Most APSSP members have lengthy summer holidays which are the envy of workers in other sectors. The downside of that benefit is the intense pressure many of us feel





At the AGM, elections will take place for four positions: Provincial President; Provincial Vice-President for Negotiations; Provincial Treasurer; and Provincial Vice-President for External Affairs. Vice-President for External Affairs is a new position on the APSSP Executive and was approved at last year's AGM. A major objective of the Provincial Executive has been to broaden our contacts with other unions in the education sector and raise APSSP's profile with the Ministry of Education. We need an experienced and dynamic V.P. External Affairs to assist in that effort.

For Provincial APSSP, the first major event of the school year is the October Educational weekend, to which Executive and Governing Council members from all Chapters are invited. The Saturday morning presentations at the Educational Weekend were followed by portfolio meetings in the afternoon. In the evening, we had the opportunity to relax and chat with members



from other Chapters at a reception and excellent buffet dinner. The first Governing Council meeting of the school year took place on Sunday. Shortly after taking over her new portfolio, Marieke Favrod, our Provincial Secretary, demonstrated her superb organizational abilities and problem solving skills in ensuring that the weekend ran smoothly. She was greatly assisted in her work by Nancy Begin, V.P. for Public Relations. Joe O'Connor arranged for our speakers and

organized the Saturday morning program.

In November, several members of the Provincial Executive met with the Provincial Executive of PSSP. PSSP, which is part of the Ontario Secondary School Teachers' Federation, is APSSP's counterpart in a number of school boards in Ontario. Although the structure of the two unions is very different, we have many issues in common. Both groups benefited from sharing information, and we hope to continue regular contact.

Two of our Chapters, Dufferin-Peel and Toronto, are feeling the effect of large budget deficits in those Boards. In both Boards, it is not yet clear to what extent APSSP positions will be affected in the long term. However, the prospect of reductions in service through delays in filling vacant positions and cuts to positions themselves are very real. The Presidents of both Chapters, Dan Milne and Glenn Webster, along with their Executives, have been very active in ensuring that all decision makers hear the message that reductions in the services provided by APSSP members have the greatest impact on our most vulnerable students. In January, Provincial APSSP wrote to the Minister of Education to register our concern that the Provincial Government has taken over the operation of the Dufferin-Peel Catholic Board from the elected trustees.

Last Spring we introduced the new APSSP logo. In the Fall, Nancy Begin continued her updating of the look of the APSSP newsletter by printing in full colour. Nancy is now taking the lead in updating the look and content of our PR materials. Our current PR material is well written and relevant. However, APSSP has grown, and we provide a wider range of professional services to students. Our PR needs to reflect the changes which have taken place. You will see more of our new look at the AGM.

Vice-President of **Negotiations**

We are pleased to announce that a settlement was reached with the St. Clair Catholic Chapter on February 16. 2007, and was approved by the Membership and the School Board the following week. I would like to

take this opportunity to thank the Negotiating Team, and in particular, Lenora Cavacas, Chief Negotiator, and our Consultant, Larry Robbins. This Agreement is for a two year term, from September 2006 to August 31 2008, with an average salary increase of 10.9%, inclusive of a Pay Equity settlement. There were also Benefit enhancements for Vision: \$300.00 every 24 months plus a free annual eye examination; hearing aids: \$500.00 every 5 years; Chiropractic and Physiotherapy: \$35.00 a visit with a maximum of \$400.00 annually; sleep apnea equipment, and Insulin control devices coverage, as well as an increase in basic Life Insurance up to \$250,00.00. There were also enhancements in Pregnancy, Parental and Adoption Leaves, along with a supplemental plan for the waiting period for these leaves. Contract language was clarified in the area of Seniority (no loss of Seniority for employees on LTD or WSIB), and the ability to be granted Compensatory Time Off for overtime.

The opportunity to visit with this Chapter in February prior to this Settlement by myself, clearly indicated the support and determination to reach this Settlement, and this gave



the Bargaining Team the impetus to reach this Agreement. Thank you for your hospitality.

Presently, eight of our Chapters have signed Collective Agreements that expire on August 31, 2008, and one Chapter, Niagara, is presently in the early stages of Bargaining. Their Agreement expired December 31, 2006.

The Chief Negotiators and Grievance Officers met in St. Jacobs in February, 2007, and received an

excellent presentation from Larry Robbins on Obligations to Accommodate People with Disabilities. Thank you to Larry. This meeting was well represented by most Chapters. We will meet again on Saturday, April 28, 2007, at the Stone Crock Inn, St. Jacobs.

We were optimistic that a new Funding Formula to School Boards would bring stability to our APSSP Chapters. The March 24, 2007 Provincial Budget gave School Boards an average increase of up to 5%, but no new Funding Formula was announced. All of the boards were left with previous shortfalls that continue to hinder the likelihood of balancing budgets. We hope that this will not have any impact on our membership. This has been experienced in the past, in particular, with the previous deficits of some of our larger Boards. (Dufferin-Peel Catholic, and Toronto Catholic Boards). The shortage of funds has also impacted on rural Boards throughout the Province and also boards that have experienced declining enrollment. In the coming months we will continue to monitor and support our Chapters that are experiencing these shortfalls.

Lisa Lubera, an Education Officer of the Pay Equity Commission, provided an excellent overview of Ontario's Pay Equity legislation and methods of implementation. Joe O'Connor moderated the panel discussion which followed. As always, Larry Robbins, our labour consultant, held our full attention as he spoke about the realities of Pay Equity maintenance, drawing on experiences of several APSSP Chapters as well as other unions. Pat Mason and Georgia Steinhart spoke about the very different process and outcome of the Pay Equity efforts within the Dufferin-Peel and Toronto Chapters. Pay Equity maintenance is legally the responsibility of both the Employer and the Union. The reality is that the burden of ensuring proper implementation and maintenance of Pay Equity usually falls upon the Union.

In the afternoon, we were able to get together into our various portfolios. It was a great opportunity to meet all the reps from various chapters, discuss issues and share ideas.

Thanks to Marieke Favrod for her hard work in making all the arrangements.

It's Time To H.E.A.L.

Heather Mesaric is a Child and Youth Worker in the Dufferin Peel Chapter and just recently published her book, It's Time To H.E.A.L. Heather tells her personal story of physical and sexual abuse to further support other victims to break their silence. She offers clear, practical advice and strategies to assist children and youth on their journey of healing. I am very proud and honoured to share some of Heathers' thoughts about her journey and how she came to the point of courage and bravery to actually put her story into words. Nancy Begin

Sexual abuse occurs far more often than is ever reported. The ordeal is usually concealed because the victim feels guilt or shame and sees no way out. It's much easier to "bury the truth deep within oneself" than to expose the ugly reality. Now, is the time for those suffering from the affects of abuse to heal themselves and live life fully.

It's Time To "H.E.A.L." offers youths and women strategies through life enhancing affirmations, intense journal exercises and powerful reflections. Following the guidelines will help abused individuals learn to love and accept themselves while they overcome the emotional and physical struggles that linger long after abuse has ended. The author candidly reveals her life story and painstakingly unravels the journey she took to rebuild her life. Walk with her through the sadness, fear and tremendous courage of a woman determined to conquer her past.

How did I come to write this book...how did I find the strength, courage, willingness to share my life story and journey of abuse? It started when I became frustrated with the secret life I was hiding from everyone. I didn't want to be silent any longer. I wanted to claim the right to have a voice. I wanted others to know who

I really was. I didn't want to believe any longer that there was something wrong with me. I wanted to speak openly about my past, my struggles and most importantly my dreams and desires of finding peace in "my" world. I was tired of being jealous of the others around me, as they told wonderful stories of their childhood, how much they loved their parents and so on.

I started writing, first and fore most in order to heal myself. I wrote to keep myself from drowning in self destruction, loneliness and trying to contain the feeling of rage owards the men who destroyed Continued on page 8

my life when I was a child and adolescent. I started writing down my thoughts about my life and how I was affected by my past. I wrote poems to ease the pain I was feeling. I began the long and painful process of learning who I was, because I wanted and needed to change the way I was feeling about myself and the world in which I lived. I had a burning desire to shake up the world around me. I wanted to scream as loud as I could and say "wake up." I wanted to believe I could make a difference. That I could be accepted by others, no matter what my past may have been like. But first, I had to learn how to find the voice that was buried deep within me, the voice that was silenced so long ago in order for me to survive. I also wanted to find the answers to the questions that seemed to haunt me day-in and dayout. The answers, that only I could answer, because they were trapped inside me.

I began to write to rid myself of the hurt, anger and loneliness that I was feeling, but what I found instead was forgiveness, love of self, a voice that could make a difference in someone else's life, as well as inner peace and acceptance. I have found support, admiration and most of all a new purpose; the desire to share my story, so others too can find their own voice. As I look into the

mirror today and smile at the reflection I see looking back at me, I reflect back to a place in time so long ago, when that image wasn't so. I know that I have gone through many stages throughout my journey of healing. I have opened many doors that were barricaded or locked in order to achieve the selfdetermination that is so prevalent within me today. I have found inner peace, acceptance of others and myself, which of course has lead me to the final destination of freedom and broken silence – I truly have found my voice. I am in a position where my voice is being heard and hopefully understood. I want to be a voice for other survivors who are not able to find or use their own voice. I want to reveal the hidden agenda behind why some survivors hide the truth from themselves as well as others.

It's Time To H.E.A.L. is a book for all professionals or any youth 12 years or older, as well as other women survivors. Some the exercises or affirmations suggested in the book can be modified for any age group, but would need to be closely monitored to ensure the child understands the task being asked of them.
