ST. CLAIR CATHOLIC DISTRICT SCHOOL BOARD TRUSTEES RATIFY TWO-AND-A-HALF YEAR CONTRACT WITH APSSP

Trustees for the St. Clair Catholic District School Board have ratified a new two-and-a-half year contract with the Association of Professional Student Services Personnel (APSSP). The APSSP bargaining unit represents 17 employees.

"We are pleased to have reached this agreement with our employees who provide important services for our students as speech pathologists, social workers, interpreters and child youth workers," says Margaret Nelson, Director of Education. "This is the first collective agreement to be settled with our employee groups.

We are optimistic that others will follow in due course." The former contract with APSSP expired on February 29, 2004. The new agreement runs from March 1, 2004 to August 31, 2006. It includes salary increases of 3% as of March 1, 2004; 2% at September 1, 2004; and 2% at September 1, 2005. The agreement also included a signing bonus and benefits improvements.

Members of APSSP approved the agreement at a ratification meeting earlier this month.

Toronto Chapter Presentation to Trustees

On February 3, 2005 - a delegation of APSSP Executive and Negotiations Committee members made a presentation to the Program and Religious Affairs Committee (i.e. all Trustees). This was a follow-up to the very successful Trustee Reception that APSSP sponsored last April. The presentation data produced was a collaboration by the members of the negotiations committee: Julie Mazzuca-Peter, Calisto Martelli, Enir Basani, Georgia Steinhart, Marina Vanayan and Carmela Diano (Governing Council Rep.). Glenn Webster, president acted as spokesperson.

The major emphasis of the information presented, referred to APSSP support for the system initiatives and of our relatively good communications with management. Although APSSP numbers are fewer, i.e. less than 150 out of 10,000 total Board staff, our influence comes from our professionalism and positive attitude. Staff shortages in psychology and speech/language pathology were noted along with the small numbers of staff in the community relations and research departments. Again, in following up on our presentation of last year, we were able to give a brief synopsis of the work that we do. It is readily accepted that although we are small in numbers, our value with parents and students is enormous.

Trustees received our delegation warmly and their questions showed their support of our group. They specifically asked about the number of social workers in schools, feeling that there were not enough. They were also concerned about staff shortages, not realizing the reasons behind this situation. Trustees encouraged open discussion and asked for relevant data.

Our APSSP delegation were asked to stand and introduce themselves to the assembled audience, which consisted of the interim Director of Education, who was congratulated on his appointment, Superintendents of Education, Co-coordinators and other interested parties.

The presentation ended on a positive note, when Board Trustee Chair invited the APSSP delegation to a luncheon meeting, along with the Director of Education! To Glenn, Julie, Calisto, Enir, Georgia, Marina and Carmela, we say thank you and congratulations on your exemplary style and hard work in representing our chapter membership!

Things have been relatively quiet for me as Provincial Secretary. I have to admit I am enjoying the smooth flow as opposed to each month bringing a new challenge, as this is the second term as Secretary of APSSP. Right now, the Membership Directory is my central focus and it seems there have been many changes particularly in the larger chapters, which may be an indication of either an aging group, or a positive change in politics!! Vice-President of Negotiations

Georgia Steinhart

At the beginning of the school year, eight of the nine APSSP Collective Agreements had expired. Consequently, this year has been an exceptionally busy one for the Chief

Negotiators. In February, the Niagara and St. Clair Chapters finalized Collective Agreements with their Boards. Under the strong leadership of Stan Brown in Niagara Chapter and Lenora Cavacas and Stephanie Orrange in St. Clair, both Chapters obtained excellent settlements. We own a special thanks to consultant Larry Robbins for his excellent work in assisting these two Chapters with negotiations.

Niagara Chapter has obtained a 3% increase to salary and benefits for each year of a three year Collective Agreement. The position of Psychological Associate was recognized in the Collective Agreement, and members in that category received a substantial wage increase. The Niagara Collective Agreement has stated working hours, and this agreement adds language providing 1.5 times compensation in wages or time off for members required to work beyond the normally scheduled working hours. The current wage gains are in addition to the Pay Equity settlement obtained last Spring which brought substantial wage increases to most of the job categories within the Niagara Chapter. Niagara Chapter members have moved from being amongst the lowest paid within APSSP to above the median for our Union.

The new 2.5 year St. Clair Collective Agreement provides for wage increases equating to 3% of average annual salary on March 1, 2004, and 2% of average annual salary on each of September 1, 2004 & 2005. The Chapter opted for pay increases as dollar amounts rather than percentages. That is, each member received the same dollar increase applied to his/her annual salary. The amount of the dollar increase is calculated by applying the agreed percentage to the average annual salary. This method slightly reduces the discrepancy between the lowest and highest step on a salary grid. In addition, each member received a signing bonus of \$750 (prorated for part time employees). The Collective Agreement also brought an increase in the Vision Care benefit and



University Degree allowance. New language in the agreement provides some protection against "contracting out".

As of the writing of this report, two Chapters are involved in bargaining with their Boards, and three Chapters are preparing for negotiations. Some Chapters have opted to wait for teacher settlements before entering into negotiations with

the employer. Two Chapters have taken advantage of the opportunity to have APSSP consultant, Leon Brumer, assist the bargaining team in understanding the Ministry's funding formula and their school board's budget.

APSSP members need to be aware of the November 29th letter sent by the Minister of Education to School Board Chairs and Directors of Education. This letter stated salary guidelines for upcoming Collective Agreements with all school board staff. The letter also required school boards to provide a public explanation of where the money would come from if these guidelines were exceeded. The Minister's guidelines provides for a 2% increase in salaries in 2004/05 and 2% in 2005/06. Presumably to encourage longer Collective Agreements, the guidelines allow for a 2.5% increase in 2006/07 and 3% in 2007/08. While the guidelines can be expected to strongly influence management wage proposals, it is important to note that guidelines are not legislated wage controls.

In addition to our meeting on the October Educational Weekend, the Chief Negotiators, along with the Grievance Officers, met at St. Jacob in February. We heard an excellent presentation by Larry Robbins on Basic Issues in Negotiations and Evaluating Your Benefit Provisions. The Chief Negotiators and Grievance Officers will be meeting again in St. Jacob at the end of April.

In May, I will reach the end of my second term as Provincial APSSP Vice-President for Negotiations. It has been a great pleasure and a deeply satisfying experience to work with the other members of the Provincial Executive, the Chapter Chief Negotiators, and other members of the Chapter Executives. I would like to thank the members of APSSP for allowing me this opportunity.

Vice-President of Grievance & Constitution

We have had a relatively quiet year in relations to grievances. I hope that some of the reasons for this have been our



This year we have had Larry present on the basics of collective bargaining, very appropriate since most chapters are currently involved in the process. Mary Hart will be presenting in April (its only March as I write this) and judging from her presentation in October, it will be informative, relevant and entertaining.

The grievance manual is completed and available. We hope it will serve as a guide and "how to do" for us. Thank you for all those involved. Like all publications in this information age, we are able to update and correct any typographical errors. It will be available on our website.

There have been a number of enquiries, which were settled before becoming grievances over placement on the grid with appropriate recognition for similar, related and relevant previous work experience. Chapter executives have a duty







to inform and assist (new) members who may not be aware of possible remuneration for previous experience. We also have a duty to " remind and assist" management who occasionally forget this.

Encourage all members to read and be aware of the Collective Agreement, benefits and the LTD plan, if you have one. Encourage managers to read it too!

The constitution is something that we constantly update to reflect the changes to our association and our employment situation. The current constitutional changes that we tried to tackle were articles 27 and 28 which deal with Codes of Conduct (among members) and Sanctions to members. The constitution is also available on our website.

We have a sunset clause allowing executive members to serve no more than two consecutive terms. After this next AGM I will have one more year before forced retirement (or alternative assignment). I would like to know if anyone is interested in taking up this role of dealing with grievances and guarding the constitution. I would be pleased to pass on what I have learned and give support to my successor.

In the meantime, as always, please do not hesitate to call me
